4. <u>President's Report – Blaire Velichko</u>

- Notification of AGM were posted on the MHMHA website and social media, as well, email reminders were sent to all members.
- 2021/2022 Season still faced a few COVID restrictions, that said the kids were able to play full season and enjoy the game they all love.
- The association hired GM, Hockey Josh Fauth and Manager, Player and Coach Development Brandt Becker.
- Special Committee created in the past year to oversee the changes in website, policies, and procedures. A substantial amount of work was done in the past 6+ months. A new website to launch soon, where members will have access to a lot more information than previously.
- Special Committee created in the past year to assist in Player/Coaching Development. MHMA looking to utilize SAHA for help from the grassroots level.
- Special Committee created in the past year for Tournament/Sponsorship/Fundraising. Janis Entem was also hired to help fill these gaps.
- Kailey Sprunger works within the MHMHA Office and manages the ice for the Association. We feel this will provide better synergies across the association.
- U17AAA Team was added to our Association for the upcoming season. We feel that a daytime program operated under MHMHA/SEAC and contracted to SAHA is the best fit moving forward based on the availability of ice. It was realized the communication on how this would work for the upcoming season was confusing and could have been better.
- The following changes are coming to our Association for the upcoming season"
 - o U13AA moving to 1 team
 - U11AA new team(s) this year. We have been assigned 2 teams from Hockey
 AB. A formal application has been submitted to request 1 team (if possible)

5. GM Report – Josh Fauth

Professional Development Plan currently under construction, in consultation with SAHA.

- Hockey Development camps to be offered throughout the year for player and coaches.
 The focus will be on the development in all age groups. The hopes are to offer parent clinics as well.
- Coach mentorship program to be development in the coming year.
- We piloted a Captains Club this past year, with involvement from Willie and the Tigers. The premise of the club is to invite teams leaders and coaches to participate in a meeting to provide further development. The goal is offer this throught the 2022-2023 season.
- We as an Association know the importance of Community Involvement. The goal in the coming years is to find more ways to be involvement in Community initiatives.

6. Events (Tournament/Fundraising/Sponsorship) Report – Janis Entem

- Janice is able to do a lot of the leg work for all City Tournaments, saving members a significant amount of time.
- All tournaments have been booked for the upcoming season. It will be a stay and play format.
- Fundraising online 50/50 starting in September. We have seen other Associations across the province have success with similar fundraising.
- Looking to start a scholarship fund for the coming season for graduating players. This of course will be dependent on our fundraising and sponsorship efforts.

7. Financial Report – Alicia Doud

- PO system created to help track expenses. All purchases made throughout the Association require receipts to be submitted prior to reimbursement. This has been a significant improvement from previous years.
- Membership was slightly down from historical levels, likely driven by the lingering effects of COVID.
- Year-end Financial Statements to be posted to website upon completion from the accountants.

8. <u>Consideration of Director Reports</u>

9. Q & A for All Reports

- Question where does SAHA fit into the MHMHA mix? SAHA will help with the Coach Mentorship, similar to P3, but in much more in depth. We are still working through the logistics of how this will look and feel.
- Question Does Hockey Hounds still provide sponsorship? Yes, they are still providing sponsorship of \$30K/year.
- Question Are practice plans going to be provided for U7 and U9 again? Hockey Alberta intro Hockey was provided to each coach. Practice Plans were outlined for each practice. It was the expectation that all coaches were to follow the Intro to Hockey plan provided at the beginning of the season. Survey to be sent to the Members of the Association for feedback on this Hot Topic.

- Question Are there any changes to how the Tournament Funds will allocated to Teams across the organization (rep vs. city)? Organization working towards finding a structure that could be fair across all levels of the Association. Stay tuned for more information.
- Question What is happening with the U17AAA? We are following closely with Hockey
 AB and hopes to get a formal answer very soon (likely within the next week). Members
 will be sent more information within the next couple of weeks. Association realizes this is
 getting down to crunch time. How will funds be allocated? Will still operate as a not-forprofit. MHMHA/SEAC to contract out to SAHA. MHMHA will/needs to revisit Payment
 Structure for all Elite Streams.
- Question What is Plan B (Re: U17AAA)? If Hockey AB declines proposal, then we move back to standard structure as we currently run our Elite teams. MHMHA will send a more detailed email outlined the U17AAA program being proposed.
- Question Can MHMHA follow-up with Lethbridge Association re: U18AAA team. (i.e. what is there plan considering it is a zone team)? Yes, we can reach out to Hockey AB and Lethbridge Association to get some clarity.
- Question what happens to the U17AAA with SAHA when the SCHL team is created in future years? Nothing happens to the U17AAA team, it will remain with our Association. A Memorandum of Understanding (MOU) will be created for so we have a multi-year plan in place with SAHA.
- Question can we look to add another CAHL team with the U15 division? Unfortunately, it comes down to Ice. We can not continue to add teams if there is no ice. With the Moose now back on the table, the decision was to add another CAHL team U11 & U13 as this is where the most members/numbers lie. This will be taken away for further discussion at an upcoming Board Meeting.
- Question where are we landing on the U13 Division re: CAHL? ID skate will be held in the fall to determine where we feel the best fit will be (i.e 2 – tier 1 and 1 tier 2/3, or tier 1, 2 and 3).
- Question any talks moving back to U13 A & B? Numbers will need to be reviewed and discussions to take place at an upcoming Board Meeting.
- Question Can we look to re-structure the City League, i.e City Standings, Playoffs, etc.?
 This has been addressed and will be outlined in our new policies and procedures. Our new website will be able to accommodate standings, etc.
